## Course Prerequisites

### Course Description

This course covers "logic of experimental design, concepts of control, ethical issues in the conduct of laboratory and applied research, and analysis of experimentally obtained data."

#### Course Overview

This course will explore the principal research methods used in psychology; teach you some of the skills necessary to conduct research; help you to be better informed and more careful evaluators of research conducted in psychology, medicine, public health, etc.

### Course Objectives and Outcomes

As a result of taking this course, you will

- Learn the principal research methods used in psychology
- Learn some of the skills necessary to conduct research in psychology, which include (a) how to formulate testable research questions (*aka* hypotheses); (b) how to approach the statistical analysis of the data and (c) how to communicate the purpose or rationale of your study and how it was conducted, as well as your findings in a manner that is both clear and consistent with formally accepted standards of scientific reporting. You may find it helpful to approach this course as one

would a language course, because in many ways the purpose of this course is to teach you the "language" of psychology.

- Share with others the intellectual excitement that can come from the pursuit of knowledge
- Learn to apply information obtained to your future endeavors, academic or not

### Course Format

This course will consist of a combination of lectures, discussions, hands-on demonstrations, debates and games to help you master the content.

### **Grading**

Grades will be based on **two exams, completion of CITI training, a research proposal topic, a theory paper, a method section paper and a full research paper.** Also, a number of extra-credit opportunities will be available throughout the semester. Your grade will be calculated as a percentage (out of 200 points) on the basis of the following scoring:

- 1. Two exams (80 total, 40 points each)
- 2. Completion of CITI training (10 points)
- 3. Research proposal topic (10 points)
- 4. Theory paper (20 points)
- 5. Method section paper and associated materials (35 points)
- 6. Final research paper and associated materials (45 points)

Minimum percentage points (and actual points) required for each final grade are as follows: A = 93 (186), A = 90 (180), B + 88 (176), B = 83 (166), B - 80 (160), C + 78 (156), C = 73 (146), C - 70 (140), D + 68 (136), D = 63 (126), D - 60 (120). If you are taking this class Pass-Fail you must earn a C - 00 better to earn a passing grade.

A grade of <u>incomplete</u> is normally not given, unless there are highly extenuating circumstances that are documented in a timely manner. When such circumstances occur prior to the deadline for dropping a course, students are encouraged to drop the course rather than request an incomplete.

The instructor will be posting your scores for exams and assignments and EC points throughout the course of the class on ANGEL. In an event of a grade dispute, email the instructor and arrange an appointment. Note that instructor will *not* engage in a grade dispute over the phone.

All written assignments and associated materials should be turned in at the beginning of the class on the day they are due unless otherwise indicated. All written assignments should be turned in as hard copies, no emails. There is a 10% penalty for each day an assignment is late, without exception, with the first penalty occurring at 11:15 AM and each subsequent penalty occurring at 24-hour intervals thereafter. Note: do not turn in late assignments under an office door or in a mailbox – it might be several days before someone finds it, and the penalty will be assessed based on when your instructor first sees it. Make sure to physically hand your written assignments to the instructor. Do not submit your late assignments by email.

### Exams

As shown on the course calendar, the course has been divided into two units. There will be one exam per unit. The exams will only cover material presented in their respective units. Also, there is no cumulative final exam, and students will be told in advance what material the final exam will cover. All exams will consist of a variety of formats, including, but not limited to: multiple choice, matching, and true-false questions. Students are expected to take all exams during class on the announced exam dates. In an event of highly extenuating circumstances (e.g., death of a close relative or serious personal illness), please contact the instructor ASAP. You will be asked to provide **a written documentation**, and a make-up might be arranged. Minor illness, death of a person other than a close relative, etc., is *not* excused.

# Research Proposal Topic, Theory Paper, Method Section Paper, and Final Research Paper

For this class, you will have to write an APA-style research paper that answers a research question of your choice. Because you will have to collect data to answer your research question, this will be a group project. The class will be split into 10 groups of three. You will have a choice to select your partners, but if you do not find partners by **Jan. 30<sup>th</sup>**, I will assign you to a group. *Each group will have to agree on a research question, design a study that answers their question, prepare all the materials for their study, coordinate and complete data collection and conduct data analyses together.* However, all members of each group will write a Research Proposal topic, Theory Paper, Method Section, and Final Research Paper *independently, without consultation with each other*.

Guidelines for all papers and supplemental materials will be provided in class and placed on ANGEL. You are strongly encouraged to contact the instructor—individually or as a group—to assist you with any questions you have at any stage of the project.

If a group member does not contribute at various stages of the project (e.g., does not participate in formulating research question, preparation of research materials, data collection and analyses), it is the responsibility of other group members to inform the instructor about the situation. Group members who have not completed their shared group work will be penalized, up to 100% for an assignment. Additionally, each group member will have to sign an acknowledgment that they have equally contributed to the shared work load of this project. No free riders are allowed in this class!

# Research Proposal Topic

Your research proposal topic should be a succinct description (1 page, double-spaced) of a research question you will be addressing in the final research proposal paper. The deadline to submit it is **Feb 6<sup>th.</sup>** Important: no individual will be allowed to submit Theory Paper if (s)he has not submitted their research proposal topic. Your research topic has to be approved by the instructor before you can start working on your Theory Paper. If you submit your Theory Paper without submitting your Research Proposal Topic paper, you will receive 0 points for both assignments!

Importantly, when deciding on a topic for your research, please keep in mind the following guidelines by FGCU Office of Research and Sponsored Programs (currently under consideration, provided by Sandy

Terranova, Research Compliance Coordinator, <a href="mailto:sterranova@fgcu.edu">sterranova@fgcu.edu</a>). To avoid submitting an IRB application for class projects, the research must be limited in scope, will not lead to generalizable knowledge or be shared outside of the classroom and **DOES NOT**:

- 1. Collect personal information (name, SSN, or any code or combination of codes that can be linked to a participant's identity)
- 2. Involve the use of vulnerable participants (i.e. children, persons who suffer from impaired cognitive functioning prisoners, residents in a nursing home, etc.)
- 3. Involve asking participants about illegal activities such as shoplifting, underage drinking, prostitution, the use of drugs, immigration status, etc., which place the study participant and/or data at risk of subpoena
- 4. Potentially pose a risk of breach of confidentiality for its participants, such as one that asks about socially stigmatized behaviors and attitudes
- 5. Place participants at risk due to emotionally charged subject matter (including rape, sexual abuse, child abuse, suicide)
- 6. Involve sensitive topics such as sex or sexuality, death including suicide, drug use of any type, drinking alcoholic beverages, violence or violent acts, failure and/or inadequacy, depression, etc.
- 7. Involve deception
- 8. Involve participants who do not speak English as their primary language
- 9. Involve physically or psychologically invasive, intrusive, or stressful procedures
- 10. Have the potential to place the individual at more than minimal risk

If you are unsure whether or not your research topic meets these guidelines, consult your instructor before submitting your research proposal topic.

## Theory Paper

As we'll cover in class, theory and explanations are very important to psychology research. At the same time that we cover the important components of different research methods toward the beginning of the semester, students will also be thinking of a research question that you would like to investigate in your Method Section and Final Research Paper. To answer the research question, students will need to identify a theory that can be applied to the topic. The theory paper is a first part of your final research paper, i.e. *Introduction*. Your research question should be supported by *at least 5 research papers/chapters* relevant to the topic that you chose. A paper describing the research question and summarizing and explaining prior research on the theory will be due on **Feb. 27**<sup>th</sup>.

## Methods Section Paper and Supplemental Materials

This assignment will include three components: (a) Method Section itself, (b) an informed consent you will be using for your study, (c) and all necessary experimental materials you need to conduct your study (e.g., questionnaires).

For all student projects, it is recommended by the FGCU IRB that the studies are conducted following ethical standards which include the use of a <u>written consent form</u>, voluntary withdrawal from a study, confidentiality procedures, and other practices that would be appropriate if the exercise were an actual research study. Therefore, be prepared to write a consent form that you will be using for your data collection.

# Final Research Paper and Supplemental Materials

The final paper should be an APA-style report, that includes cover page, abstract, introduction, method, results, discussion, references, figures and/or tables and appendix (if needed). You are required to revise your *Introduction* and *Method* sections to incorporate feedback you will receive from your instructor on Theory and Methods papers. We will collect data for your project using your classmates, however, you are allowed to recruit other participants as well (e.g., students from other classes, friends). You will analyze your data using SPSS software in class. A sample research paper will also be placed on ANGEL to assist you in writing your final paper. Please approach the instructor with any questions you might have regarding this paper during office hours. Your final submission will consist of (a) SPSS output to show your data analysis, (b) your

graded Theory and Methods papers and (c) your final research paper. The deadline for submission, **Apr. 16th**, will be strictly enforced.

## Extra Credit (Grade Insurance)

A number of EC opportunities will be available and will be described throughout the course and placed on ANGEL. Note that you cannot earn more than 2.5% (5 points) of your grade on all your extra-credit assignments.

## Important Recommendations

Mastering "language of psychology" requires that students work regularly and avoid procrastination and cramming. Attend every class session. Read the text and complete assigned homework prior to the lecture that covers the material. Come to the instructor's office hours for extra help.

Regular class attendance is strongly recommended but not required. Some of the material discussed in class is *not* covered in your textbook. Students missing class are responsible for all material presented in class and for any modifications to the course calendar that are announced in class. If you expect to miss a class, make arrangements beforehand *with a classmate* who takes good class notes.

Prior to each exam, a review session will be held during regular class time. This session is *not* intended to replace class attendance and doing the homework on a regular schedule. *Prior* to the review session, you should have identified your areas of weakness and formulated your questions.
